**AN ORDINANCE DEFERRING INCREASES
TO SEWER USER RATE CHARGES**

ORDINANCE NO. 2018-09-01

WHEREAS, the Board of Trustees of the LAKES REGION SANITARY DISTRICT, Lake County, Illinois, adopted Ordinance 11-11-01 on November 10, 2011 setting user rates for the Sanitary District;

WHEREAS, the Board of Trustees of the LAKES REGION SANITARY DISTRICT, Lake County, Illinois, adopted Ordinance 2015-12-01 on December 10, 2015 amending Ordinance 11-11-01;

WHEREAS, Ordinance 11-11-01, as amended provides for a series of increases to user rate charges, based upon the Consumer Price Index, but the Board deferred the increase scheduled to go into effect on May 1, 2016 and again on May 1, 2017;

WHEREAS, the Board of Trustees has determined it is advisable to defer further increases to user rate charges until the Board approves a change by Ordinance and that it is in the best interest of the residents not to increase the user rate charges at this time.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LAKES REGION SANITARY DISTRICT, Lake County, Illinois, as follows:

SECTION 1: The above stated recitals are incorporated by this reference.

SECTION 2: The scheduled cumulative increase in sewer user rates for May 1, 2016 that was previously deferred shall continue to be deferred.

SECTION 3: The sewer user rate charges shall remain at the current rates until further action by the Board to change the rates by the adoption of an ordinance to that effect. This Ordinance shall not impact increases to the rates charged by other units of government and billed by Lakes Region Sanitary District.

SECTION 4: If any provision of this Ordinance shall be found by a court of competent jurisdiction to be ultra vires or unconstitutional, such provision shall be considered excised here from and shall not affect the enforceability or validity of the remaining provision herein.


SECTION 5: That this Ordinance shall be in full force and effect from and after its passage and approval.


